How to Use This Directory

This directory helps you find court information for any of Oklahoma's 77 counties. Each county has its own district court. The courts are grouped into 26 judicial districts.

Finding Court Information on OSCN

OSCN stands for Oklahoma State Courts Network. It is the official online portal for Oklahoma court records. Follow these steps to find court information:

- Go to www.oscn.net and click on "Courts" in the menu
- Select your county from the list, or use the search feature
- The county court page shows contact info, judges, and clerk details
- For case lookups, use the docket search at www.oscn.net/dockets
- For e-filing, visit www.oscn.net/e-filing

Understanding Judicial Districts

Oklahoma groups its 77 counties into 26 judicial districts. Each district shares judges across its counties. Some districts have one county. Others have up to nine counties. The district number tells you which set of judges serves your county.

What Each Column Means

The directory tables show these details for each county:

Column	Meaning
County	The county name
County Seat	The main town where the courthouse is located
Judicial District	The district number (1-26) that serves this county
OSCN Court Link	Web link to the county's OSCN court page
Clerk Contact	How to reach the court clerk (phone or OSCN page)
